**Oceania Regional Finals Update**

- Wendy O'Sullivan provided an update –
  - The judge and photographer are booked and VRHA are ready to release the show schedule.
- Karen Callinan - Run for a Million qualifier at OC finals –
  - Australia via the OC will be the only country outside of the US to host a live qualifier.
  - Eligible classes are – Non-Pro and Rookie (any level) and are run using US eligibilities not Oceania eligibilities
  - The classes will be run concurrent with a \$200 AUD entry fee
  - Top 5 qualifiers will be awarded a Run for a million Rosette

- ✓ Motion – That the qualifier for RFAM is run as part of the OC Regional Finals
  - Carried. All in favour
- 2021 Regional Finals Partnership Packages reviewed.
  - The sponsorship will be for 12 months, independent start dates to be recorded and sponsors to be contacted prior to end of sponsorship to ascertain if further sponsorship could be forthcoming.
  - Sponsors will be advertised at Regional Finals and on social media
  - Money is to go into the VRHA account. All funds are recorded and allocated to the OC via the VRHA Bookkeeping system.
- ✓ Motion – That 2021/2022 sponsorship will be used for the 2022 finals.
  - Carried. All in favour
- ✓ Motion – The value of sponsorship will be \$400.
  - Carried. All in favour
- An electronic vote will be taken regarding the sponsorship package once it is updated to allow distribution before next council meeting.
